## **Opt-Out Form for Online Learning Graduation Requirement**

Information About the Online Learning Graduation Requirement:

Students are required to earn two online learning credits to graduate from an Ontario secondary school, beginning with every student who entered Grade 9 in the 2020-2021 school year. The graduation requirement is intended to support students in developing familiarity and comfort with working and learning in a fully online environment, as well as developing digital literacy and other important transferable skills that will help prepare them for success after graduation and in all aspects of their lives.

Meeting the online learning graduation requirement should not pose as a barrier to graduation for students. As with all learning, students taking online courses will have access to the supports they need through their school, (e.g., guidance, extra-curricular activities).

Parents/guardians may choose to opt their child out of the mandatory online courses required for graduation. Students aged 18 years of age or older can also opt out of the graduation requirement. Schools must also allow for students and parents/guardians to opt back into the online learning graduation requirement should their decision change.

The average cost for an online course for Ontario high school students is \$500-\$600. This cost will be covered by each individual family.

- (6) This will be recorded on my child's/my transcript as "Online Learning Graduation Requirement Non-Applicable".
